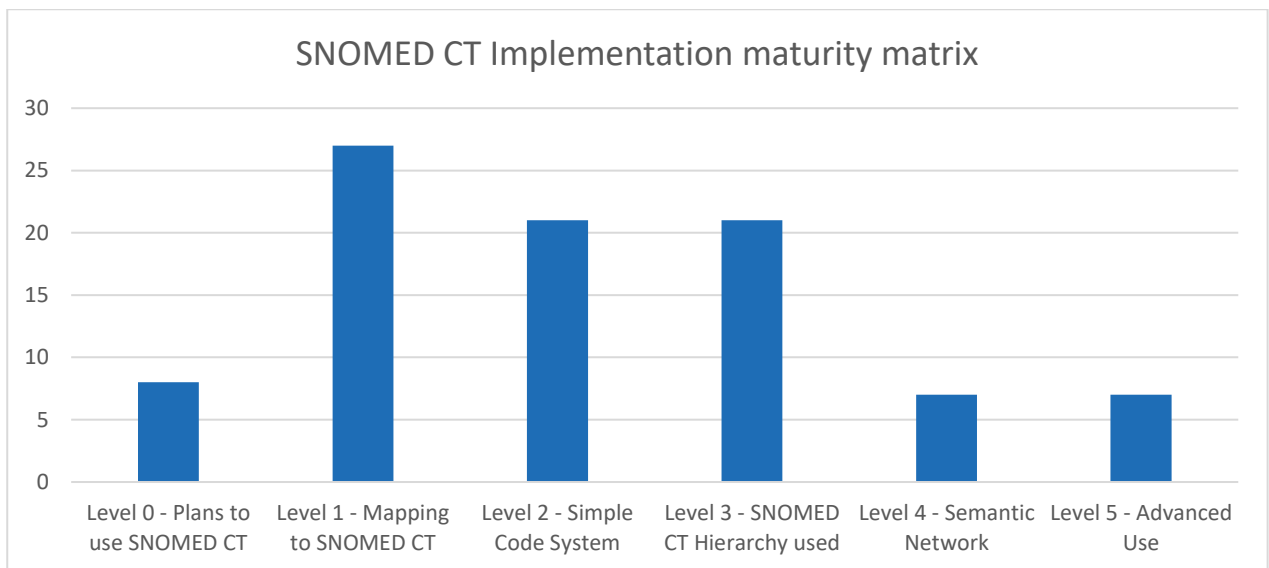
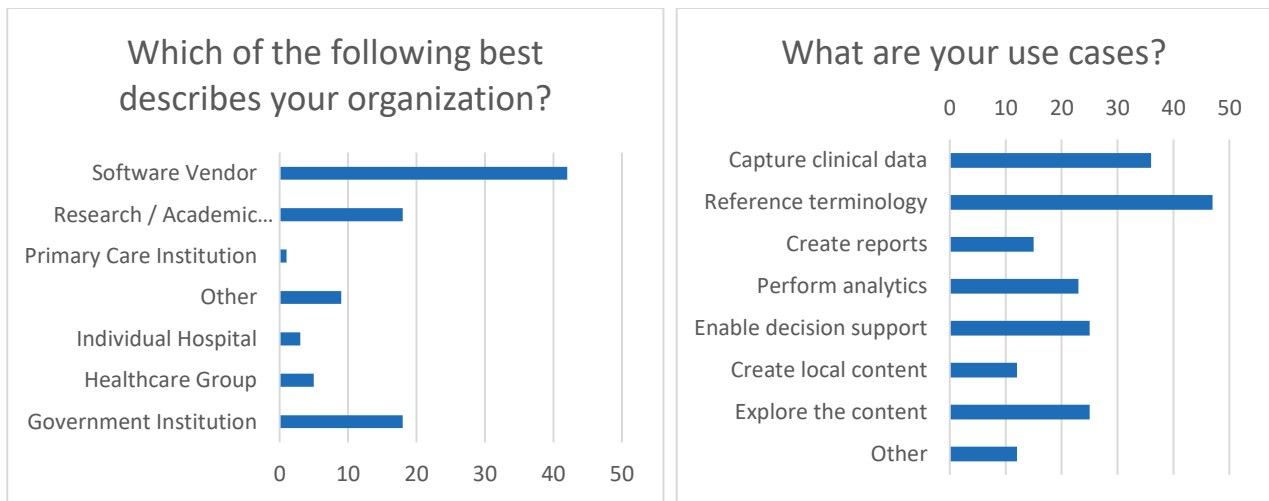

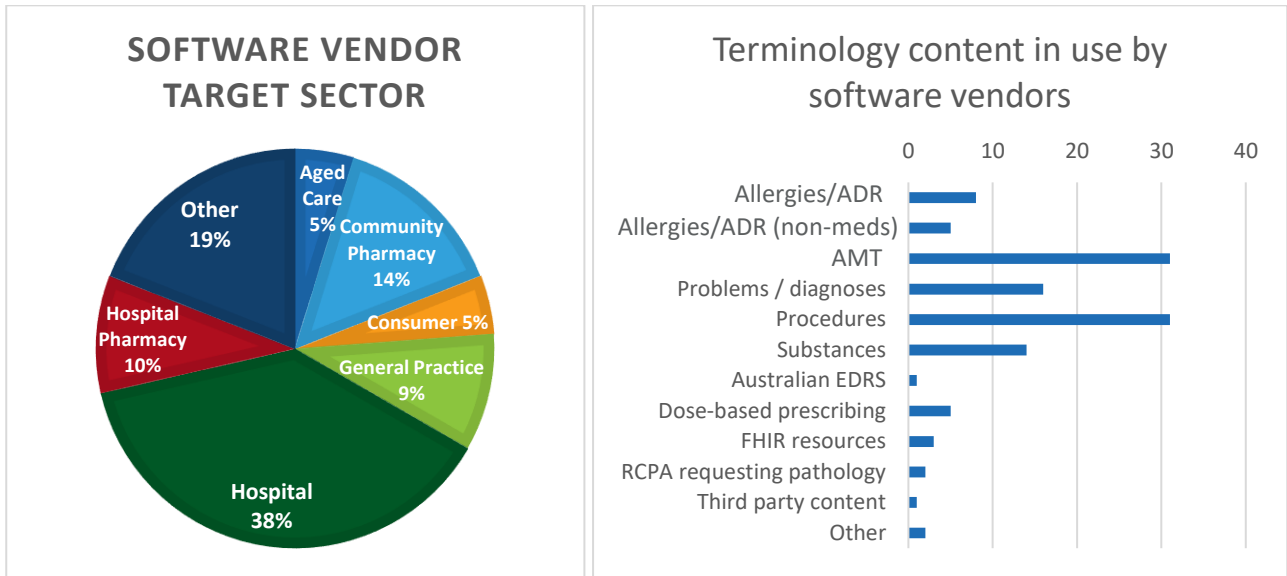
New or planned SNOMED CT education activities in your region

- **Webinars**
 - Terminologies and Classifications: SNOMED CT-AU and ICD-10-AM use in Australia (Feb 2020)
 - Principles of mapping
 - Search/data capture principles
- **One-on-one meetings and workshops with vendors and implementers**
- **Workshops**
 - We held a second “Terminology adoption and meaningful use” workshop with representatives from the health departments of Australian states and territories to discuss how health classifications (e.g. ICD-10-AM) are being used in Australia, and current issues relating to the use of national terminologies and health classifications to identify potential solutions and ultimately drive better uptake by all jurisdictions (who are our primary funders)
 - Next topics will include search and data capture principles, and data analytics
- **Co-chair community support groups: the Australian Clinical Terminology User Group (AuCT-UG) and AMT Support Group (AMTSG)**
 - Forums to share updates regarding SNOMED International activities
 - Includes standing agenda items that explore a particular feature of SNOMED CT and how it is implemented
 - Implementation experience, learnings and work by external stakeholder – not only of terminology but health classifications and data analytics with some relevance to terminology
 - Governance re AMT modelling, editorial or roadmap decisions

- Terminologies and classification use in Australia
- SNOMED CT and AMT Usage Survey was completed 28 February 2020
 - The purpose of this survey is to gather information about SNOMED CT / AMT use and benefits in order to inform our product and service development, and better support the user community.
 - 118 complete individual responses, 96 indicated they were currently using SNOMED CT / AMT, preliminary results are below.
