

We look forward to the opportunity to showcase the Korean healthcare IT and present SNOMED CT applications in front of SNOMED CT communities!


1. Developed a Roadmap for Healthcare Data

Korea has developed a 5-year roadmap for standardization of healthcare data including terminology, technology and person-generated health data at the national level. In so doing, the country has shared a common goal to promote collaboration among industry, academia and public sector ultimately to make the best use of various data generated throughout the entire healthcare ecosystem.



2. National Project to Enhance Interoperability


In 2016, the Korean government set a policy basis to establish the Health Information Exchange System through standardization at the national level in order to ultimately to contribute to enhancing public health. Under the policy, the government initiated the 'Health Information Exchange Project'. As a result, as of 2021, about 7,000 medical institutions participated in the project, which has made the healthcare service guaranteed with its continuity. With the project, we are committed to enhancing data quality and usage in the health information exchange by applying domestic and global standards including SNOMED CT.

3. National My Health Data Project

The My Health Data Project was designed to empower the public to be more in control of decisions regarding their data and their well-being. The public has a right to access their health data collected from various sources such as clinical settings, public agencies and mobile devices. The public also has right to contribute their data to the parties who would like to use their data based on the informed consent. This will lead to the public to manage their data and their well-being in a self-determined manner. To that end, 'My Healthway System' based on the standardized national API system was established. Since this project meets the requirement of the global standards such as SNOMED CT and FHIR, health data exchanged in the system will ensure semantic interoperability.




4. Data-Driven Hospital Network

The data-driven hospital network project enables to establish a data set spanning a whole life cycle of healthcare data to support researches for the public interests.

The data-driven hospital network has created an innovative healthcare data ecosystem that includes around 70.4 million patients' data in Korea.

Especially, led by the national cancer big data project, data-driven hospitals organized consortiums to exchange and share reference sets of liver, colon, stomach, breast, and lung cancers developed using SNOMED CT.



Laying a Foundation for Facilitating Joint Researches by Multiple Organizations

5. Use of SNOMED CT in Hospitals

The Korean tertiary hospitals have developed various use cases of SNOMED CT to promote patients' safety and improve healthcare service. Especially, SNU Bundang Hospital, a leading digital hospital, has implemented SNOMED CT in EMR to improve patient outcome through data standardization. SNU Bundang Hospital is being recognized as a global model of digital hospital since it became the first Asian medical center to achieve HIMSS EMRAM Stage 7 in 2010 and received certifications of HIMSS EMRAM Stage 7 in 2016 and 2019.

Samsung Medical Center (SMC) has spearheaded data standardization by introducing a Connected Platform to integrate the state-of-the-art technology into medical treatment. These efforts enabled the SMC to become the world's first medical center to achieve HIMSS INFRAM Stage 7, HIMSS EMRAM Stage 6, as well as HIMSS DIAM Stage 6. SMC was recognized as the 1st ranked hospital in Korea and the 30th ranked hospital globally by the Newsweek in the category of the Best Smart Hospital. SMC also was acknowledged as one of the most technically advancing medical centers around the world.






6. Industrial Usage of SNOMED CT

Digital healthcare business operators in Korea have made various attempts to utilize SNOMED CT in their businesses. For instance, Kakao Healthcare, a Korean leading digital platform provider, plans to build a platform of digital healthcare ecosystem in which SNOMED CT is applied for the purpose of enabling customized health management service. ezCaretech, a business specialized in healthcare data system, has developed and implemented BESTCare 2.0, a SNOMED CT and HL7 Technology applied EMR solution and has been exporting the solution to 19 medical centers overseas.

7. Application of SNOMED CT in Medical Specialty Academic Society

The Korean Spinal Neurosurgey Society recognized the importance of standard terminology to enhance the value of big data the society collect. The society introduced data set for spinal neurosurgey and established SNOMED CT map in order to promote collaborative researches among multiple medical institutions. The scope of data set includes diagnoses and surgical procedures. The data set will be used in developing the CDMs of big data. By doing so, the awareness of benefits of standard terminology will be improved and this will lead to use of standard terminology within the society held seminars during the society's annual academic conferences and created a 10-member working group within the society.

Attendance & Vendor Participation

Attendance

Korea has hosted business meetings of various international health standard development organizations such as WHO-FIC, ISO/TC 215, and HL7 with a great success in the past. One of success factors was hosting these meetings in alignment with the bi-annual meetings of the Korean Society of Medical Informatics(KOSMI). Korean Ministry of Health will try to host SNOMED Business Meetings and Expo with the help of the KOSMI to facilitate participation of the KOSMI members.

Koran Ministry of Health initiated health IT projects such as Health Information Exchange, data-driven hospitals, PHR called My Healthway, Electronic Medical Record System Certification and development of SNOMED CT Korean extension based on National Health Standard Roadmap. Ministry of Health will encourage and support participation of the researchers from Academia, industry and research institute in the SNOMED Business Meetings and Expo.

Regarding international participants, we would like to utilize the Korean Society of Medical Informatics' established network with China and Japan called CJK MI (China-Japan-Korea Medical Informatics). We hope SNOMED Business Meetings and Expo is a good opportunity to invite the experts from China and Japan. This will provide an opportunity for Chines and Japanese experts to learn SNOMED CT and use of SNOMED CT in EMR.

Vendor


In Korea, even though adoption rate of electronic medical record (EMR) systems reaches the top. Korean Ministry of Health introduced EMR Certification in 2020 to ensure quality of EMR data and improve patient safety. As of October 2022, 83 EMR vendors and 3,921 hospitals were certified. Use of standard health terminology will be one of criteria for interoperability domain in a near future. SNOMED CT will be one of standard health terminologies.

EMR certification certainly made EMR vendors keen on learning SNOMED CT. SNOMED business meetings and Expo will provide opportunities for Korean EMR vendors to learn how vendors in other countries implement SNOMED CT and how SNOMED CT is being used.

Besides EMR vendors, Korean tech giants such as Samsung and LG, and tech platform such as Naver and instant messenger such as Kakao are producing various patient generated health data (PGHD). These companies have shown great interest in standard clinical terminology to find ways of better use cases of PGHD by linking to clinical data.

In this regard, Korea will encourage and attract vendors in various healthcare industries to take part in the SNOMED CT International 2024 October Business Meetings & SNOMED CT Expo 2024.





Local Transport



Seoul Metro

Seoul Metro operates one of the world's largest urban railway networks, comprised of Subway Lines 1 to 8 and the second and third sections of Subway Line 9. Trains run non-stop from approximately 5:30 am until midnight. The first and last train schedules vary depending on the subway station.

Bus

Seoul's public bus system is a well-developed, cheap, and convenient. All buses are color-coded: blue for main city route, green for subway stations, and smaller green maeul (local) for shorter routes within a single district or neighborhood, and red for connecting the city with surrounding areas.

Taxi

Taking a taxi in Korea is very convenient for international visitors. Taxis can be found at taxi stands in most busy city areas or hailed on the streets. Some taxis can be called by phone or mobile application. The base fare in Seoul is KRW 3,800 won (approx. USD 3), and the fare rises by time and distance traveled.
