#### INTRODUCTION

- SNOMED CT mapping is extensive, flexible for input of clinical terms but may be incomplete in certain unmapped ICD 10 codes. The mapping from SNOMED CT to International Classification of Diseases – 10 (ICD-10) is necessary for disease reporting systems.
- The Morphology of Malignant Neoplasms, which is a nomenclature of codes designed for use in conjunction with Chapter 11 Neoplasms, has not been included in the MAP.(1)
- SNOMED CT to ICD 10 mapping needs to be examined prior to its integration as standardised input terms in disease surveillance systems such as disease registries.
- This paper examines completeness of SNOMED CT to ICD 10 mapping for Malignant neoplasms, Diabetes mellitus and Diseases of circulatory system.

#### **OBJECTIVES**

- To understand the completeness of mapping of SNOMED CT to ICD -10 classification for specific non-communicable diseases.
- To identify gaps in mapping of SNOMED CT to ICD-10 coding for reporting non-communicable diseases particularly diseases of cardiovascular system, diabetes and malignant neoplasm.
- To examine the feasibility of integration of SNOMED CT into disease registries for non-communicable diseases.



#### DISCUSSION

- >95 % ICD codes have SNOMED CT descriptions mapped in Diseases of neoplasm (C00-C97)and circulatory system (I00-I99)
- Seven ICD-10 codes (E10-E14) are not mapped to SNOMED CT terms
- Incompatible SNOMED CT to ICD 10 mapping found in Diabetes (5 terms) and in Diseases of Circulatory system (4 terms)
- Though there are additional SNOMED terms for specific ICD codes, there are ICD descriptions that are missed in SNOMED descriptions
- SNOMED terms relevant to above NCDs that are not mapped to ICD codes are 677 (neoplasms), 472 (circulatory system) and 112 (diabetes). SNOMED terms that define and describe NCDs need to be mapped to ICD 10 codes.

#### CONCLUSION

 This study helps in identifying gaps in the translation of coding systems (SNOMED to ICD). These could be addressed to improve coding accuracy, especially in the context of the global preparedness for ICD-11 classification.
