	Administration of anesthesia hierarchy	Zac Whitewood-Moores	<p>From Zac Whitewood-Moores :</p> <p>"Consider the hierarchy under</p> <p><<410770002 Administration of anesthesia for procedure (procedure) </p> <p>... They do not discriminate between general anaesthetic, sedation, spinal, regional and local anaesthetic.</p> <p>I believe that separating the anaesthetic from the procedure and recording both is really the only scalable way forward. I would be grateful if the Anaesthesia CRG could consider this area of content/requirement and make the appropriate request of SNOMED International</p> <p>... My suggestion is that this hierarchy is retired... a less palatable one would be that they are disambiguated and modelled with both procedures to ensure equivalence can be determined.</p> <p>Either way needs care to ensure that it does not appear that two surgical procedures have been undertaken in the clinical record."</p> <p>Reviewed with the group, and we generally agree that this hierarchy is overly post-coordinated. It appears to have historically been derived from the US CPT anesthesia codes (00xxx codes).</p>
